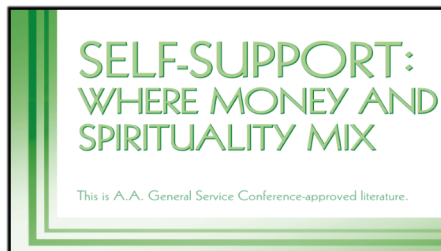

DCMC REPORT FOR HAPPENINGS MARCH 2018

We unfortunately had to cancel our trip to the Pacific Region Alcoholics Anonymous Service Assembly (PRAASA) earlier this month in Sparks, Nevada as we erred on the side of not getting stuck in the blizzard.

It was a bummer, but local Past Delegate Ken M., who left early for the event, did purchase the PRAASA audio MP3s for me and if anyone wants a copy, just contact me.

Now, me and other local General Service meddlin' kids, will still be making a road trip in the Scooby-Doo Mystery Machine (a rented commuter van) up to the Summer Assembly later this year.

Speaking of assemblies, the Pre-Conference Assembly will be April 7th and 8th in San Jose. This is where General Service Representatives (GSRs) let our Delegate Joann L. know what their groups thought about this year's Agenda Topics. Santa Clara County South, District 40, made a motion at the California Northern Coastal Area's monthly meeting in Petaluma last month that should be of interest to all AA members.

"That the Trustees' Literature Committee consider adding to their agenda publishing a 5th Edition of the Big Book, Alcoholics Anonymous, with updated stories to more broadly reflect our current fellowship, as well as updates or additions to Appendices III and V."

It will be a motion of new business at the Pre-Conference Assembly in April, meaning that questions will only be entertained on the wording and intent of the motion, not open discussion. Then, at the Post-Conference Assembly on May 12 at the Solano County Fairgrounds in Vallejo, it will be new business and discussion will commence.

When the motion becomes old business, it can, after thorough discussion, then be voted on. If it passes, then our Delegate would send a letter to New York stating the motion and the process of how it got that far and it could possibly become an Agenda Topic.

I have three questions: first question, do you have an opinion on whether we should proceed with Big Book 5.0? Second question, does your group have a GSR? Third question, if not, why not you?
